

**ARTICLE XIII
ADOPTION**

Sec. 1301 VALIDITY

Should any section, clause or provision of this Ordinance be declared by the courts to be invalid, the same shall not affect the validity of this Ordinance as a whole or any part thereof, other than the part so declared to be invalid.

Sec. 1302 CONFLICTING ORDINANCES

All other ordinances and parts of ordinances, or amendments thereto, of Pere Marquette Charter Township in conflict with the provisions of this Ordinance are hereby repealed.

Sec. 1303 EFFECTIVE DATE

This Ordinance shall take effect on June 1, 1994 upon publication in the Ludington Daily News.

Sec. 1304 APPROVAL AND PASSAGE

The foregoing Pere Marquette Charter Township Zoning Ordinance/Zoning Maps was approved by the Mason County Zoning Commission on April 5, 1994; following a public hearing conducted by the Pere Marquette Charter Township Planning Commission on January 18, 1994.

The proposed ordinance was introduced by the Pere Marquette Charter Township Board at a regular meeting held on April 12, 1994; was posted on April 13, 1994; was approved and adopted by the Township Board of the Charter Township of Pere Marquette, Mason County, Michigan, on May 10, 1994, pursuant to Act 184 of the Public Acts of 1943, as amended, and was given effect upon publication in the Ludington Daily News on June 1, 1994.

The Township Clerk was instructed to publish the same in the Ludington Daily News on June 1, 1994, a newspaper of general circulation in said Township, as required by Act 359 of the Public Acts of 1947, as amended, and to further deposit an attested copy of the same with the Mason County Clerk, as required by Act 191 of the Public Acts of 1939, as amended.
